This memo requests approval to establish fiscal year 2018 (FY18) program budgets for the Renewable Energy Fund (REF) as set forth in the Funding Allocations by Program Table on page 2. Further, Staff requests approval to take the following program actions:

- Reopen the Residential Solar & Wind Rebate program to only current waitlisted applications;
- Invite public comment on modifying the rebate level and other program terms and conditions of the Residential Solar & Wind Rebate program;
- Reopen the Commercial and Industrial Solar Rebate program (Category 1 and Category 2) to only current waitlisted applications.

Analysis

The table below summarizes the REF balance and program funding available for FY18 (July 1, 2017 through June 30, 2018), net of administrative costs and funds previously encumbered or committed:

To satisfy the program funding requirements of RSA 362-F, including the addition of a Low Moderate Income program, and to provide adequate funding to fully fund current waitlisted applications, Staff recommends the following program allocations:

Residential Solar & Wind Rebate Program

The funding allocation for the Residential Solar & Wind Rebate program allows all waitlisted applications to be funded under current program terms and conditions. The waitlist totals approximately \$600,000 leaving an unallocated balance equal to approximately \$250,000. Staff recommends that the

Commission reopen the Residential Solar & Wind Rebate program to accommodate waitlisted applications, but keep the program closed to new applicants.

Further, with a current maximum rebate per residential installation equal to \$2,500, this fiscal year's program unallocated balance would only incentivize approximately 100 new residential installations. To maximize the benefits of this limited funding, Staff recommends that the Commission consider changes to the rebate level and other program terms and conditions. Staff proposes that the Commission schedule a public comment hearing, the purpose of which would be to better understand market conditions and determine if program terms and conditions should be modified prior to reopening the program to new applicants. To expedite the procedure, Staff will develop recommendations for program revisions prior to the hearing. Staff will continue to monitor the program for expired applications and will provide updated available funding estimates prior to or during the hearing.

Commercial and Industrial Solar Rebate Programs

The funding allocation for the C&I Solar Rebate Program allows only waitlisted Category 1 and Category 2 applications to be funded under current program terms and conditions. The waitlist for the program is \$990,231. Assuming all waitlisted applications are approved, fiscal year funding will be fully allocated. Staff therefore recommends that the Commission reopen the C&I Solar Rebate Program to accommodate administration of waitlisted applications, but keep the program closed to new applicants. Staff will continue to monitor the program for expired applications. Given there will most likely be no uncommitted funds in the near term, Staff recommends that the Commission not initiate a process to consider changes in program terms and conditions at this time. Staff anticipates a discussion regarding program revisions may be more appropriate in early 2018.
