Petition for Approval of Lease Agreement between PSNH dba Eversource Energy and Northern Pass Transmission LLC

PETITION TO INTERVENE OF Rebecca Hutchinson

Rebecca Hutchinson respectfully petitions the New Hampshire Public Utilities Commission ("PUC") for late intervention in the above-captioned proceedings under RSA 541-A:32 and PUC Rule 203.17, because the proposed facility will impact the rights, duties, privileges, immunities and other substantial interest of Rebecca Hutchinson and the interests of justice and orderly and prompt conduct of the proceedings will not be impaired by allowing the intervention.

In support of her request, Rebecca Hutchinson states as follows:

- On or about October 19, 20015, Public Service Company of New Hampshire ("PSNH") d/b/a Eversource Energy (Eversource) filed a Petition of Approval of a lease agreement (Lease Petition) between Eversource and Northern Pass Transmission LLC ("Northern Pass") pertaining to certain real estate interests of Eversource. Northern Pass also filed an application with the SITE Evaluation Committee ("SEC") to construct, operate, and maintain a 192-mile, high voltage electric transmission line from the international border between New Hampshire and Canada to a substation in Deerfield, New Hampshire.
- Rebecca Hutchinson and Jonathan W Hutchinson own 21 acres of land and our home which is situated along the proposed route for the Northern Pass project. Proposed poles 3132-280 and 281 abut our property directly. This property is encumbered by a PSNH ROW easement.
- 3. The proposed Lease Petition will impact the rights, duties, privileges, immunities and other substantial interests of Rebecca Hutchinson. We are concerned that this proposal may substantially affect our family's property. Allowing this intervention will serve the interests of justice and will not impair the orderly and prompt conduct of the proceedings.

- 4. On January 29, 2016, the PUC issued an Order of Notice requiring interested parties to intervene by February 17, 2016. Since then, Parties have submitted filings but the underlying substance of the Lease Petition has not yet been adjudicated by the PUC> This matter has not progressed substantially such that permitting the late intervention would prejudice the Applicant.
- 5. Rebecca Hutchinson respectfully requests that the Public Utilities Commission grant her Petition to Intervene and such other and further relief as may be just.
