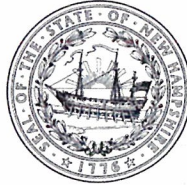

Dear Mr. Carrigan:

On February 11, 2016, the Commission received an application prepared by Berlin Water Works requesting Class IV renewable energy certificate (REC) eligibility for the Ammonoosuc Water Treatment facility. Pursuant to RSA 362-F:4, IV(a), Class IV hydroelectric facilities are required to have begun operation prior to January 1, 2006. According to the application submitted by Berlin Water Works, the Ammonoosuc Water Treatment facility began operation on August 27, 2015. The facility therefore is not eligible to qualify as a Class IV facility.
