

**THE STATE OF NEW HAMPSHIRE****SUPREME COURT**

**In Case No. 2017-0007, Appeal of Algonquin Gas Transmission, LLC; Appeal of Public Service Company of New Hampshire d/b/a Eversource Energy, the court on February 15, 2017, issued the following order:**

The appeal filed by Algonquin Gas Transmission, LLC and the appeal filed by Public Service Company of New Hampshire, both from a decision of the New Hampshire Public Utilities Commission, are accepted and will be scheduled for oral argument before the full court.

This case appears to be eligible for mediation pursuant to Rule 12-A. Under Rule 12-A(2), the agreement of all parties is required for appellate mediation. If all parties in this case agree to participate in mediation, Algonquin Gas Transmission, LLC shall submit the completed Appellate Mediation Agreement form to the court on or before March 2, 2017. An Appellate Mediation Agreement form (NHJB-2614-SUP) is being provided to Algonquin Gas Transmission, LLC with this order. If an Appellate Mediation Agreement form is not filed, an order will be issued regarding further proceedings.

Each attorney who is not a member of the New Hampshire Bar and who intends to participate in this case shall file a verified application to appear pro hac vice in accordance with Rule 33(1) on or before March 2, 2017. The application should be accompanied by the non-refundable application fee of \$250.00 or by evidence that the fee was previously paid in a related or consolidated matter. See Rule 33(5).
