# PETITION OF GRANITE STATE GAS TRANSMISSION, INC. FOR LICENSE TO CONSTRUCT AND MAINTAIN A DISTRIBUTION GAS MAIN ACROSS PUBLIC WATERS

Granite State Gas Transmission, Inc. ("Granite") respectfully petitions the New Hampshire Public Utilities Commission ("Commission") pursuant to RSA 371:17 for a license to construct and maintain a natural gas distribution main over public waters owned by the State of New Hampshire. In support of this Petition, Granite states as follows:

- 1. Granite is an interstate natural gas transmission pipeline company, operating 86 miles of underground gas transmission pipeline located primarily in New Hampshire and Maine. Granite provides its affiliate, Northern Utilities, Inc., with critical interconnection to major natural gas pipelines and access to domestic natural gas supplies in the south and Canadian natural gas supplies in the north.
- 2. Specifically relevant to this petition, Granite operates and maintains a segment of its gas transmission pipeline in the State of New Hampshire's right of way along the Spaulding Turnpike and NH RT 16 in the City of Dover ("Dover").
- 3. The State of New Hampshire Department of Transportation ("NHDOT") is currently implementing a major highway project that includes, among other things, the widening of the Spaulding Turnpike / NH RT 16 in Dover. In connection with this project, Granite is relocating its 10″ diameter gas transmission pipeline to the eastern edge of the State's right of way.

- 4. A portion of Spaulding Turnpike / NH RT 116 abuts Pomeroy Cove, which is part of the Piscataqua River and a New Hampshire tidal estuary. In connection with the above-described NHDOT project, Granite will relocate the segment of its gas transmission pipeline that currently exists within the State right of way along the edge of Pomeroy Cove to a location in the right of way that passes under Pomeroy Cove.
- 5. The relocated gas transmission pipeline will pass under approximately 1,300 feet of Pomeroy Cove, up to 25 feet from the approximate high tide line and at an approximate depth of 40-45 feet below ground. Granite will use the Horizontal Directional Drilling method to install the relocated 10" diameter pipeline consistent with the technical specifications attached hereto as Attachment A. Horizontal Directional Drilling is a trenchless method of installing pipeline that is accomplished in multiple stages, including site preparation, equipment setup, pilot bore, reaming, pulling the pipeline through the drilled bore, and site restoration. A stress calculation and analysis report for the 10" diameter pipeline to be located under Pomeroy Cove is attached hereto as Attachment B.
- 6. The Horizontal Drilling Process and relocation of the gas transmission pipeline will not present issues of environmental or safety related concern. Granite has completed notification regarding the project to the New Hampshire Department of Environmental Services ("NHDES") and the Army Corps of Engineers. *See* Wetlands Utility Maintenance Notification attached hereto as Attachment C (with file number).
- 7. The relocation of Granite's gas transmission pipeline under Pomeroy Cove is a necessary prerequisite to the NHDOT's efforts to widen the Spaulding Turnpike / NH RT 16 in Dover. It is also critical to the continued provision of natural gas to the region.

- 8. Granite believes that the Commission license requested above will be exercised without substantially affecting public rights in affected waters. The proposed relocated gas transmission pipeline will not present any impediment to or safety concern for marine traffic in Pomeroy Cove. The relocated pipeline will not impose any additional burden upon the public interest and it will allow Granite to continue provide critical natural gas supply to the region.
- 9. Granite wishes to commence construction in the relocation project described herein in May 2016 to maximize the 2016 construction season. As such, Granite respectfully requests that the Commission grant the requested license on an expedited basis.

WHEREFORE, Granite respectfully requests that the Commission:

- A. Find that the license for the relocation of Granite's natural gas transmission pipeline currently existing in the State right of way along Spaulding Turnpike / NH RT 16 in Dover to an area under approximately 1,300 feet of Pomeroy Cove may be exercised without substantially affecting public rights in State waters;
- B. Grant Northern a license to relocate and maintain a natural gas transmission pipeline under approximately 1,300 feet of Pomeroy Cove; and
- C. Issue an order *nisi* and orders for its publication.
