Subject: DRM 16-508 Update

To the DRM 16-508 Service List-

On August 19, 2016, the Commission adopted an "Initial Proposal" for the readoption with amendments of the Puc 800 rules regarding Underground Utility Damage Prevention Program. The adopted Initial Proposal contains relatively minor language edits and formatting changes from the August 1, 2016 draft version of the proposed rules amendments, including the re-formatting of the following four sections:

- 805.03 (a) (b) (c), renumbering the remaining
- 805.01 d (4),
- 803.01 (b) (6)
- 807.06 (b)

The adopted Initial Proposal, together with the Fiscal Impact Statement prepared by the Legislative Budget Assistant, will be filed with the Office of Legislative Services Administrative Rules Division to continue the formal rulemaking process.
