**Re: First Calendar Quarter 2021 Emissions Verification Summary for New Hampshire
Certified Biomass Renewable Energy Sources**

Dear GIS Administrator:

New Hampshire Renewable Portfolio Standard eligibility determinations of generation facilities that use biomass fuels are conditional, as required by RSA 362-F:11, III. Within ten days of receiving the quarterly notice from the New Hampshire Department of Environmental Services (DES) that a facility has met DES emissions standards, the Commission must designate each facility as eligible to produce Renewable Energy Certificates (RECs).

Based on the DES recommendation received electronically on May 6, 2021, the Commission hereby certifies the following wood-fired power plants listed in **Table 1-A: Calendar Quarter 1, 2021 – N.H. REC Eligible Biomass Power Plants**, provided below, as renewable energy sources for the first quarter of 2021. These facilities met average emissions rates of 0.02 lb/MMBtu (or an alternative plan), and 0.075 lb/MMBtu for total suspended particulate (TSP) and nitrogen oxides (NO_x), respectively.

DES reported the facility in **Table 1-B: Calendar Quarter 1, 2021 - N.H. REC Ineligible Biomass Power Plants** as ineligible to receive N.H. Class III designation for any production reported during the first quarter of 2021 due to noncompliance with emissions testing requirements. As this facility's NO_x emissions rate exceeded 0.075 lb/MMBtu, it is not eligible to receive N.H. Class III designation for any production reported during Q1 2021.

¹ Bridgewater Power Company qualifies for N.H. Class III RECs according to RSA 362-F:11, IV, which allows for a biomass facility that does not meet the TSP requirements, but would otherwise qualify for N.H. RECs, to submit a plan to the DES that demonstrates quantifiable emissions reductions. The plan has been approved by the DES, and the Commission has certified the facility in accordance with the plan approved by the DES.

DES reported the facilities in **Table 1-C: Calendar Quarter 1, 2021 – N.H. REC Ineligible Biomass Power Plants** as “not operating” during Q1 2021. As these facilities were non-operational during the quarter, emissions rate testing was not conducted, and these facilities are not eligible to receive N.H. Class III designation for any production reported during Q1 2021.

Quarterly Emissions Verification Summary reports will no longer list previously approved thermal facilities that are rated less than 3 MMBtu/hr design gross heat input, as they are required to meet best management practices determined by the DES during initial eligibility certification and do not require quarterly testing and approval. **There is one newly eligible small (<3 MMBtu/hr) thermal renewable energy source certified during Q1 2021: RREC #20-1617, GIS unit ID NON153361, was approved on February 9, 2021 for a facility at the Society for the Protection of New Hampshire Forests, 54 Portsmouth Street, Concord, NH. The N.H. Certification Number for that facility is NH-21-IT-0035.**
