Dear Mr. Kern:

On June 23, 2017, SmartEnergy Holdings, LLC (SmartEnergy), a competitive electric power supplier currently authorized to provide service in the franchise area of Public Service Company of New Hampshire, d/b/a Eversource Energy, filed a request to expand its service area to include the franchise area of Unitil Energy Systems, Inc. (Unitil). With its filing, SmartEnergy included a copy of a certificate demonstrating it had completed electronic data interchange testing with Unitil.

Staff reviewed the filing and recommended the Commission approve the request, in a memorandum filed on June 26, 2017. The Commission has reviewed SmartEnergy's filing and Staff's recommendation, and has approved SmartEnergy's request. Accordingly, SmartEnergy is authorized to expand its service area to include the franchise area of Unitil, effective as of the date of this letter.
