On December 1, 2016, Northern New England Telephone Operations, LLC d/b/a FairPoint Communications-NNE (FairPoint) filed an Interconnection Agreement with Onvoy Spectrum, LLC (Onvoy), pursuant to 47 U.S.C. §252(e). Onvoy elected to adopt the Interconnection Agreement between AT&T Wireless Services, Inc. and FairPoint predecessor Verizon New England d/b/a Verizon New Hampshire, pursuant to 47 U.S.C. §252(i). The original Interconnection Agreement between AT&T Wireless Services, Inc. and Verizon New England Inc., d/b/a Verizon New Hampshire, was allowed to go into effect by operation of law on or about March 7, 2001, in Docket No DT 00-276.

Onvoy registered as a telecommunications carrier in New Hampshire on December 31, 2014, under TCID 511.

Staff recommends that the Commission allow the adoption of the Interconnection Agreement to go into effect by operation of law 90 days after originally having been filed. In this case, the Agreement will become effective on or about March 1, 2017.
