Re: DT 17-091: Intrastate Access Tariff Filings by Telephone Carriers: Airus Inc.

Dear Mr. Phipps:

On June 20, 2017, Airus, Inc. (Airus) submitted a filing to revise its intrastate access tariff for effect on July 31, 2017, pursuant to the Federal Communications Commission (FCC) Report and Order FCC 11-161 (Transformation Order).

However, Airus is not registered as a telephone utility in New Hampshire. (If Airus provides voice service exclusively through Voice over Internet Protocol, it does not need to be registered, and indeed cannot be registered, as a telephone utility here.) Since the Commission's authority to accept and approve tariffs is limited to those submitted by telephone utilities, the Airus submission has no effect. Airus is voluntarily registered as a telecommunications carrier in New Hampshire, but that does not enable the Commission to act on its tariff filings.
