On July 14, 2017, Bandwidth.com CLEC., LLC (Bandwidth.com) submitted a filing to revise its intrastate access tariff for effect on July 29, 2017, pursuant to the Federal Communications Commission (FCC) Report and Order FCC 11-161 (Transformation Order).

However, Bandwidth.com is not registered as a telephone utility in New Hampshire. (If Bandwidth.com provides voice service exclusively through Voice over Internet Protocol, it does not need to be registered, and indeed cannot be registered, as a telephone utility here.) Since the Commission's authority to accept and approve tariffs is limited to those submitted by telephone utilities, the Bandwidth.com submission has no effect.
