Re: DT 17-091: Intrastate Access Tariff Filings by Telephone Carriers: West Telecom Services

Dear Ms. Wightman:

On July 14, 2017, West Telecom Services (Delaware) (West) submitted a filing to revise its intrastate access tariff for effect on July 29, 2017, pursuant to the Federal Communications Commission (FCC) Report and Order FCC 11-161 (Transformation Order).

However, West is not registered as a telephone utility in New Hampshire. (If West provides voice service exclusively through Voice over Internet Protocol, it does not need to be registered, and indeed cannot be registered, as a telephone utility here.) Since the Commission's authority to accept and approve tariffs is limited to those submitted by telephone utilities, the West submission has no effect. West is voluntarily registered as a telecommunications carrier in New Hampshire, but that does not enable the Commission to act on its tariff filings.
