On July 14, 2017, BullsEye Telecom, Inc. (BullsEye) submitted a filing to revise its intrastate access tariff for effect on July 29, 2017, pursuant to the Federal Communications Commission (FCC) Report and Order FCC 11-161 (Transformation Order).

Staff reviewed the proposed tariff changes for compliance with FCC orders and rules, and following its investigation, recommended that these proposed changes be allowed to go into effect.

The Commission has accepted Staff's recommendation that the proposed tariff changes be allowed to take effect. For administrative efficiency, an order will not be issued by the Commission either suspending, rejecting, or approving the proposed tariff changes. Pursuant to RSA 378:3 and RSA 378:6, IV, the proposed tariff changes, filed on July 14, 2017, and pursuant to Staff's recommendation, are effective, as proposed, on July 29, 2017.
