On September 26, 2017, DSCI Corporation / DSCI, LLC (DSCI) submitted an intrastate access tariff filing pursuant to the Federal Communications Commission (FCC) Report and Order FCC 11-161 (Transformation Order). This tariff revision took effect by operation of law on October 25, 2017.

Staff has reviewed this filing for compliance with FCC orders and rules. This tariff revision reduces rates for particular rate elements as required by that Order, and increases rates for other rate elements where allowed by that Order. Our review has included comparison with the recently revised access tariff of Northern New England Telephone Operations, LLC (FairPoint), which is the "price cap carrier" in New Hampshire and whose intrastate access tariff therefore serves as a cap on rates filed by certain other providers.

The filing appears to be consistent with FCC directives. There is no need to direct DSCI to revise the tariff. Staff recommends that DSCI be directed to file a compliance copy of this revision with an effective date of October 25, 2017.
