Scheduling of Discovery Conference

To the Parties:

On October 26, 2017, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource), J. P. Morgan Securities, LLC (JP Morgan), and Commission Staff (Staff) (collectively the Auction Parties) filed a joint motion requesting a discovery conference to resolve discovery disputes from three intervening municipalities, the City of Berlin and the Towns of New Hampton and Bristol (Municipal Intervenors) as well as a request for waiver of certain Commission procedural rules.

On October 27, 2017, the Municipal Intervenors filed a response to the joint motion in which they did not object to the request for a discovery conference, but asked that such a conference be scheduled no earlier than November 2, 2017 and also requested the Commission waive certain procedural rules.

The Commission has scheduled a discovery conference to be held at the Commission offices at 21 S. Fruit Street, Suite 10, Concord, New Hampshire, beginning at 8:00 a.m. on Thursday, November 2, 2017 at which time the Commission will consider the discovery disputes and the related rules waivers.
