Enclosed for filing in the above reference proceeding is a Revised Clerk's Report for the hearing held October 13, 2017. At that hearing, the Chairman left the record open for a data request wherein the Company would file revised rates to reflect correct information concerning the cost of LNG inventory, as of late August 2017. Tr. at 95. At the hearing, all parties agreed that such a submittal would give the Commission the information it would need to approve the revised tariffs, if it so decided. Tr. at 95 -96.

On October 20, the Company filed the revised rates, consisting of nine tariff pages (replacing Bates pp 45, 46, 47, 48, 49, 191, 192, 193, & 194 in the Company's original filing – Exhibit 1) all of which were labelled Exhibit 10.

This Revised Clerk's Report references this Exhibit 10, whereas the originally filed Clerk's Report did not include Exhibit 10.
