Dear Attorney Sheehan:

In Order No. 26,067 issued October 31, 2017 in the above captioned matter, the Commission ordered Liberty, among other things, to re-file its proposed cost of gas rates with all costs related to compressed natural gas removed and replaced with propane costs. On November 1, 2017, Liberty filed in compliance with Order No. 26,067, revised tariff pages which contained the following rates:

Non-Fixed Price Option Cost of Gas Rate - Beginning Period (per therm) = \$1.2533

Fixed Price Option Cost of Gas Rate (per therm) = \$1.2408

In a letter dated November 1, 2017, Staff indicated that it found Liberty's compliance filing to be in compliance with Puc 1603 filing requirements.

Accordingly, the Commission hereby approves the rates set forth in Liberty's October 31, 2017 compliance filing and as set forth above, for effect November 1, 2017.
