To the Parties:

By secretarial letter dated April 15, 2020, the Commission scheduled a hearing on April 23, 2020 on Omni Mount Washington Hotel, LLC's (Omni) motion regarding contested rate case expenses and Abenaki Water Company, Inc.'s (Abenaki) motion to extend the Step II filing deadline.
