Re: DE 17-172, Development of Renewable Energy Fund Programs for Low and Moderate Income Residential Customers Under SB 129 of 2017

To Interested Persons:

Pursuant to 2017 N.H. Laws Chapter 226 (SB 129), the Commission is required to use not less than 15 percent of the Renewable Energy Fund established under RSA 362-F:10 annually to

benefit low-moderate income residential customers, including, but not limited to, the financing or leveraging of financing for low-moderate income community solar projects in manufactured housing communities or in multi-family rental housing.

The Commission has determined to commence a proceeding to develop, review, and approve programs and procedures designed to meet the statutory requirements of SB 129. Initial efforts to develop such programs shall be undertaken concurrently with working group sessions scheduled to develop low and moderate income pilot programs in the alternative net metering docket, DE 16-576, as directed in Commission Order No. 26,029 at 63 (June 23, 2017).

Accordingly, Docket DE 17-172 is opened as a non-adjudicative proceeding and a stakeholder technical session in that docket is scheduled for November 15, 2017 at 1:00 p.m.
