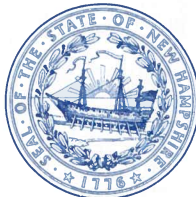

To the Parties:

On July 6, 2018, Commission Staff filed a letter recommending that the Commission modify the procedural schedule for this proceeding, in order to provide additional opportunity for continued settlement discussions among the parties. Staff indicated that the parties had agreed to cancel the hearings scheduled for July 9 and 10, 2018, and to schedule additional settlement conferences for those two days, as well as on July 23, 2018 starting at 10:00 a.m.

The Commission has reviewed and approved the recommended modifications to the procedural schedule for the docket. Accordingly, the hearings scheduled for July 9 and 10, 2018 are cancelled and settlement conferences will be held on July 9, 10, and 23, 2018, starting at 10:00 a.m. each day.
