Proposed Procedural Schedule

Dear Ms. Howland:

On December 18, 2018, the Commission held a prehearing conference in the above matter, followed by a technical session among the parties.

At the technical session, the parties agreed to respond to the pending motion filed by the Wood Power Producers on or before December 27, 2018. The parties agreed to include in the response their views on the issues listed in the Commission's Order of Notice in this docket.

The Wood Power Producers said they also wanted to file a response on December 27th. Eversource objected to this request, stating that Eversource and other parties would then need an opportunity to respond to whatever the Wood Power Producers stated in their response.

In the event that a hearing may be necessary in this matter, the parties requested that the Commission hold a hearing date in early January 2019. In addition, in light of the February 1, 2019 effective date of the power purchase period, the parties requested that the Commission on the pending petition filed by Eversource, and the motion filed by the Wood Power Producers, in early January 2019.
