Staff Recommendation to Amend Procedural Schedule

Dear Ms. Howland:

On July 13, 2018, the Commission issued a Secretarial Letter approving a change in the procedural schedule in this case. Specifically, the date for the filing of the Commission Staff's ("Staff") and the Office of the Consumer Advocate's ("OCA") respective recommendations relative to PWW's 2018 QCPAC filing was changed from August 8, 2018 to August 29, 2018. The reason for this change was so that the respective recommendations could include consideration of PWW's QCPAC quarterly update filing which was scheduled to be received by August 15, 2018.

On August 16, 2018, PWW filed its QCPAC quarterly update filing in this case. However, upon review of that filing, Staff found various discrepancies relative to the schedules provided by the Company. Staff alerted the Company to those discrepancies, and the Company submitted a revised update filing in this docket on August 23, 2018.

Given the delay in the filing of an accurate QCPAC quarterly update, as well as to enable an adequate period of time for the review of such by Staff and the OCA, the parties in this case agree and recommend that the date on which the OCA and Staff file their respective recommendations in this case should be changed from August 29, 2018 to September 12, 2018.
