# **STIPULATION**

The Lakes Region Water Co., Inc., Hampstead Area Water Company, Inc., and Abenaki Water Co., Inc., (together "Petitioners"), Office of Consumer Advocate, and Commission Staff (combined, "Parties") stipulate as follows:

In consideration of the provisions set forth in this Stipulation, the Parties request:
(a) that the request set forth in the Petition for a formal rulemaking or a declaratory ruling in this proceeding be withdrawn, without prejudice; and (b) that the request set forth in the Office of Consumer Advocate's Motion to Dismiss be withdrawn, without prejudice.

2. The Parties request that the Commission conduct a general investigation in this proceeding to consider: (a) whether to adopt one or more amendments to the Commission's rules to provide for a formula to establish rates of return on equity for small public water systems subject to statutory requirements that rates approved by the Commission be "just and reasonable" (RSA 378:7); and (b) recommendations concerning the same. The Parties believe a general investigation is appropriate because the Commission's Order of Notice indicated that the

Commission may consider the Petitioner's petition in a general investigation. See Order of Notice dated March 29, 2018, Page 2.

3. The Parties request that the Commission schedule a technical conference as soon as reasonably possible to exchange information and to adopt a schedule for futher proceedings.

4. Counsel for intervenor Omni Mount Washington indicated that Omni Mount Washington does not object to the Stipulation but that it objects to the filing of Ms. Ahern's testimony in DW 17-165, Abenaki Water Company – Rosebrook, Request for Change in Rates.

5. The Parties request that the Commission approve this Stipulation and grant such other relief as justice may require.
