Dear Mr. Smith:

On May 17, 2018 Gold Star Energy, LLC filed an application to renew its registration as a provider of natural gas aggregation service. Gold Star Energy, LLC's registration expires on July 28, 2018. Staff reviewed the application and determined that it is complete.

The Commission approves your application effective as of July 29, 2023. The registration is for a term of 5 years and expires at the end of business on July 28, 2023. Pursuant to N.H. Code Admin. Rules Puc 3003.02(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before May 29, 2023.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 - Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at:

Please note that, effective as of July 1, 2014, each registered natural gas aggregator is subject to an annual assessment of \$2,000, unless it demonstrates that its gross revenue in New Hampshire during the preceding fiscal year (from July 1 through June 30) was less than \$10,000, pursuant to RSA 363-A:2, III and 5.
