Per request of the Commission, Choose Energy, Inc. would also like to reply to the following questions:

- Did the company have NH customers and were doing business with NH customers after their initial registration expired?
Choose Energy, Inc. was found to be operating in the NH market after the initial registration expired. As soon as this was found, we submitted our Natural Gas Aggregator Initial Registration in order to reinstate our license. The lapse was found during our diligence phase of the merger.
- In the application, the company stated "...was not actively engaged in natural gas marketing in the state" – does it mean that while Choose Energy was not actively engaged in marketing but were still doing business and indirectly engaged in natural gas marketing?
Choose Energy, Inc. was found to be operating in the NH market after the initial registration expired. While Choose Energy had residual marketing active in the marketing initiated prior to the merger, we were not actively implementing marketing campaigns in the market. As soon as this was found, we submitted our Natural Gas Aggregator Initial Registration in order to reinstate our license. The lapse was found during our diligence phase of the merger.
- If Choose Energy did have customers, why did the company take six months before they decided to re-register?
Choose Energy, Inc. merged with SOE Sub Inc., a wholly-owned subsidiary of Save On Energy, LLC on June 1, 2017. The surviving entity is Choose Energy, Inc. As part of the merger, all regulatory licenses were transferred for management. The lapse of DM-15-423 was found during our diligence phase of the merger.



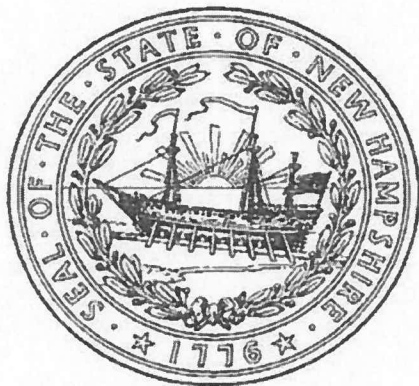
