Postponement of April 5, 2019 Hearing

To the Parties:

On March 29, 2019, Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities (Liberty) filed an assented-to motion to continue the April 5, 2019 hearing on the merits in the above-referenced matter. Liberty requested postponement of this hearing to the first date on or after May 6, 2019 agreeable to the parties, because Liberty wanted more time to review information it obtained through discovery, as well as the positions of Commission Staff (Staff) and the Office of the Consumer Advocate (OCA). Liberty represented that Staff and the OCA assented to the relief requested in its motion.

The Commission determined that Liberty's request for postponement of the April 5 hearing would promote the orderly and efficient conduct of this proceeding. Accordingly, the Commission waived N.H. Code Admin. Rules Puc 203.13(a) and granted Liberty's motion to continue. The merits hearing scheduled on April 5, 2019 is postponed until further notice. Liberty shall file with the Commission on or before May 3, 2019 proposed dates agreed to by the parties for rescheduling the merits hearing.
