Order to Pay 2018 Alternative Compliance Payments

Dear Mr. Sandford:

The New Hampshire Public Utilities Commission (Commission) previously notified Agera Energy, LLC (Agera) by letter dated September 17, 2019 that the alternative compliance payments (ACPs) Agera owes for compliance year 2018 were past due, Agera having failed to make those payments by the July 1, 2019 deadline under N.H. RSA 362-F:10, II and N.H. Code Admin. Rules Puc 2503.03(b). The Commission stated in that letter that it may pursue additional actions to enforce Agera's ACP payment obligation if Agera failed to make such payment on or before September 27, 2019. As of this date, the Commission has not received payment of Agera's ACPs, which total \$2,231,262.00, pursuant to Agera's signed Form E-2500 submitted on July 8, 2019.

Accordingly, Agera is hereby ordered to pay in full the ACPs due, in the amount of \$2,231,262.00, within 14 days of the date of this order, on or before October 16, 2019. If payment is not received in full by that date, the Commission may pursue further actions to enforce Agera's ACP payment obligation, under Puc 2005.06(c) and other applicable law and rules.
