On December 10, 2018, Liberty Utilities (Granite State Electric) Corp. filed proposed tariff changes for effect January 1, 2019. The proposed changes modify tariff pages to remove the electricity consumption tax from rates pursuant to House Bill 517, which repealed RSA 83-E, the electricity consumption tax, effective January 1, 2019.

Staff filed a memorandum on December 21, 2018, confirming that the tariff changes comply with House Bill 517.

Based on the foregoing, the Commission has approved the proposed tariff changes. Tariff pages should be filed referencing Docket No. DE 18-183 with an effective date of January 1, 2019.
