On January 28, 2019, Northern New England Telephone Operations, LLC, filed a request for a legal name change from Northern New England Telephone Operations, LLC to Consolidated Communications of Northern New England Company, LLC d/b/a Consolidated Communications – NNE, and filed adoption notices and new cover pages for tariffs NHPUC No. 2, Miscellaneous Network Services, NHPUC No. 3, Access Services, and New Hampshire PUC No. 4, Resale Services. The company requested an effective date of February 27, 2019.

Commission Staff reviewed the filing and concludes that it is consistent with applicable laws and rules. Staff has effectuated the legal name change in its records, and recommends allowing the adopted tariffs to be deemed effective as of February 27, 2019, as requested by the company.
