Petition for Approval of Modifications to Wholesale Performance Plan Approval of
Initial Procedural Schedule and Scheduling Conference Call

To the Parties:

On March 27, 2019, the Commission held a duly-noticed prehearing conference in the above-referenced matter. Appearances were entered by Consolidated Communications of Northern New England Company, LLC d/b/a Consolidated Communications-NNE (Consolidated), Charter Fiberlink NH-CCO, LLC and Time Warner Cable Information Services (New Hampshire), LLC (collectively, Charter), the CLEC Association of Northern New England, Inc., which includes CRC Communications LLC d/b/a OTELCO, FirstLight Fiber, and Biddeford Internet Corp. d/b/a Great Works Internet (collectively, CANNE), and Commission Staff (Staff). The Commission granted the petitions to intervene filed by Charter and CANNE. Following the prehearing conference, the parties and Staff met in technical session.

On April 2, 2019, Staff filed a letter requesting approval of an initial procedural schedule to which the participants agreed at the technical session. Staff stated that the initial procedural schedule included questions submitted to Consolidated for response and the scheduling of a technical session by conference call, which would include representatives of the Maine and Vermont regulatory bodies, on Thursday, April 4, 2019, beginning at 10:00 a.m.

The Commission has reviewed and approved the recommended initial procedural schedule. Accordingly, a technical session by conference call has been scheduled for April 4, 2019 at 10:00 a.m. The call-in information will be circulated by a Consolidated representative.

For administrative efficiency, the Commission has elected to issue this secretarial letter as its initial prehearing order in this proceeding.
