On April 16, 2019, the Commission held a duly noticed prehearing conference in the above-referenced matter. Appearances were entered by Liberty Utilities (EnergyNorth Natural Gas) d/b/a Liberty Utilities (the Company), the Office of the Consumer Advocate (OCA), and Commission Staff (Staff). No petitions to intervene were filed.
