Dear Mr. Huttenhower:

On March 22, 2019, Teleport Communications of America LLC (TCAL) requested that the New Hampshire Public Utilities Commission grant a "safety valve" waiver of Somos' decision to deny TCAL's request for a specific thousand-block number assignment in the Durham, New Hampshire rate center.

Staff reviewed the filing and determined that sufficient and satisfactory numbering resources exist in Durham to meet TCAL's request. Staff recommended that the Commission notify Somos to assign numbers pursuant to TCAL's request.

Accordingly, the Commission has granted TCAL's request for a "safety valve" waiver and directs Somos to assign a specific thousand-block of numbers in the Durham rate center to TCAL that meets its requirements.
