In order for companies to be eligible to receive federal high-cost support pursuant to 47 USC §254(e) and 47 CFR §54.314, the Commission must certify that any funds provided will be used only for the provision, maintenance and upgrading of facilities and services for which the support is intended. On September 24, 2018, the Commission, by Secretarial Letter, notified Staff that it delegated the authority, effective August 15, 2018, to make or deny certification to USAC regarding this program.

Each year, to ensure that the certification is accurate, Staff directs companies to submit sworn affidavits from an officer of the company authorized to make an affidavit regarding the company's use of Federal Universal Service High-Cost Support funds.
