Scheduling Evidentiary Hearing

To the Parties:

An evidentiary hearing in the above-captioned matter has been scheduled for September 28, 2020, at 9:00 a.m. It will be conducted in accordance with the remote hearing guidelines contained in the secretarial letter dated June 1, 2020.

During the hearing, the parties should be prepared to present evidence on every fact necessary to decide the issues raised, including, but not limited to: the date of the pipe installation; location of the curb-stop; location of the shut-off valve; classification of the pipe as a service line or as a main extension; the size of the pipe that ruptured and the size of the pipes connected to it, i.e., was a smaller pipe connected to the hotel and a larger pipe in the street; ownership and property interests in the pipe that ruptured the water system infrastructure (or network of pipes) between the property line at the right-of-way and the plumbing system for the hotel from the date of the pipe installation forward; location of any other valves on the ruptured pipe and their classification or identification; and location of the limit of the highway. The Commission will also hear argument from the parties on the tariff interpretation and applicability, and burden of proof issues that have been raised.
