Enclosed for filing with the Commission please find Public Service Company of New Hampshire d/b/a Eversource Energy's supplement to the above referenced petition for licenses to cross public waters and State owned land. Pursuant to the Commission's notice of March 17, 2020, this filing is only being provided by email.

This supplement includes replacement Exhibits 2 through 8 in response to requests from the PUC's Safety Division. The enclosed supplemental petition has been revised to reflect changes in measurements reflected in the replacement Exhibits 2 through 8. The original filed petition in Docket 19-162 only addressed structure replacements, but this supplemental petition and supporting Exhibits have also expanded the number of crossing locations to include an expanded project scope that includes replacing the existing static wire with OPGW over the entirety of the S136 line depicted on Exhibit 1.

Eversource respectfully requests that the Commission issue an Order *Nisi* with respect to this supplemental crossing licenses application.
