Application to Renew Registration as a Provider of Electric Aggregation Service

Dear Mr. Rasmussen:

On December 13, 2019, Blitz Ventures, Inc. d/b/a EnergyBot (Blitz Ventures) submitted an application with the Commission to renew its registration as a provider of electric aggregation service.

Commission Staff filed a memorandum on December 17, 2019, in which it confirmed its review of the application and its conclusion that the application is complete. Staff recommended that Blitz Ventures registration renewal application be approved for a two-year term, beginning on February 12, 2020, pursuant to Puc 2003.06(e)(1).

Your application for registration renewal is approved effective as of February 12, 2020, under Puc 2003.06(e)(1). The renewed registration is for a term of two years and expires at the close of business on February 12, 2022. Pursuant to Puc 2003.06(a), you must submit your next renewal application at least 60 days prior to the expiration of the approved registration term, on or before December 14, 2021.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules.
