Rebuttal Testimony by any Party to Staff & Intervenor Testimony	12/3/20
Settlement Due	12/3/20
Hearings	12/10/20, 12/14/20 (am only) & 12/16/20 (pm only)

Staff reserves the right to propose an alternative schedule if the Motion for Designation of Staff Advocates filed on September 2, 2020 by the OCA *et al.* is granted. OCA opposes Staff's attempt to reserve such right.
