In compliance with the Commission's Order No. 26,386 in Docket No. DE 20-085 (Order Approving Adjustment to Stranded Cost Recovery Charge) and Order No. 26,387 in Docket DE 20-095 (Order Approving Change to Transmission Cost Adjustment Mechanism Rates), the following tariff pages are transmitted herewith:

Effective: August 1, 2020

These tariff pages implement a decrease in the Company's stranded cost recovery charges and an increase in the transmission charges effective August 1, 2020 as approved by the Commission in the Orders referenced above.

The Commission also approved a decrease in the Company's Default Energy Service Rate DE effective August 1, 2020 in its Order No. 26,368. Revised tariff pages were filed with the Commission in compliance with this Order on July 17th, 2020.

For customers receiving delivery service only from Eversource, the combined impact of all changes is an 8.1% increase in the overall average retail rate. For customers receiving both delivery service and energy service from Eversource, the combined impact of all rate changes is a 2.8% decrease in the overall average retail rate.

Black-lined tariff pages denoting the stranded cost recovery and transmission charge changes effective August 1, 2020 have been submitted for easy identification of the changes.

Supplemental Information on the Filing

The enclosed “Summary of Rates” reports summarize all the rates and charges in the Company’s tariff by month, rate class and rate component. In addition, we have enclosed a schedule of “Typical Bill Comparisons” based on the rates in effect on February 1, 2020 and the new rates. The monthly bill amount (including default energy service) for a residential customer served under Rate R and using 600 kilowatt-hours, previously \$114.72, will decrease to \$111.69 on August 1, 2020, a decrease of \$3.03 or 2.64%.

It should be noted that a more appropriate comparison is to rates in effect for the same period a year ago. When the new rates are compared to the rates in effect on August 1, 2019 (a similar period), the monthly bill amount for the same residential customer will decrease from \$121.36 to \$111.69 on August 1, 2020, a decrease of \$9.67 or 8.0%.

In its Order No. 26,386 in Docket No. DE 20-085 (Order Approving Adjustment to Stranded Cost Recovery Charge), the Commission also directed the Company to recalculate the average SCRC rate to exclude net metering costs and reallocate stranded costs in rates among various customer classes as appropriate, and to file subsequent new calculations and allocations. These are also included in this filing as updated Attachment ELM-6.
