To the Parties:

On November 9, 2020, the Commission held a duly noticed prehearing conference in the above-referenced matter. Appearances were entered by Public Service Company of New Hampshire d/b/a Eversource Energy, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Utilities, Unitil Energy Systems, Inc., the Office of the Consumer Advocate, and Commission Staff (Staff). The Commission granted petitions to intervene filed by: Clean Energy New Hampshire; New England Convenience Store & Energy Marketers Association, Inc.; Conservation Law Foundation; ChargePoint, Inc.; the New Hampshire Department of Environmental Services; and the City of Lebanon.

Following the prehearing conference, the participants met in a technical session and agreed upon the following schedule, which Staff submitted to the Commission by letter dated November 12, 2020:
