By secretarial letter dated June 15, 2021, the Commission directed the parties to this proceeding to develop and propose a procedural schedule designed to resolve the outstanding matters in this proceeding at least 30 days prior to February 16, 2022, the date hearings are scheduled to conclude in Docket No. DE 21-030.
