**Electric Vehicle Time of Use Rates**

**Motion for Remote Participation**

Liberty Utilities (Granite State Electric) Corp., d/b/a Liberty, through counsel, respectfully moves the Commission pursuant to Puc 203.07 to allow for two Liberty personnel to remotely monitor the January 31, 2023, hearing in the above matter.

In support of this motion Liberty, states the following:

1. By procedural order dated November 23, 2022, the Commission scheduled a January 31, 2023, hearing “to provide Eversource and the parties with an opportunity to address matters pertaining to Eversource’s assumptions, design, and cost estimates for its proposed EV TOU tariff and its proposed EV metering Pilot.” The procedural order further states that, “[f]ollowing Eversource’s presentation and Commission questions, the Commission will allow questions and comments from parties concerning the EV TOU Tariff and the Pilot.”
2. Liberty does not intend to ask questions of Eversource at the hearing nor does Liberty intend to provide comments. However, Liberty would like to have two people monitor the proceeding remotely.
3. Greg Tillman is a Senior Manager, Rate Design. Mr. Tillman’s team supports rate cases filed by Liberty’s affiliates throughout the country and is working on Liberty’s upcoming

rate case, in which information from this hearing may prove useful. As Mr. Tillman is based in Florida, it is not practical for him to appear at the hearing in person.

4. Dmitry Balashov is Liberty's Senior Director of Grid Modernization and is based in Liberty's corporate office in Oakville, Ontario, Canada. Mr. Balashov is responsible for grid modernization efforts at Liberty affiliates across the country and is also advising on EV issues that may be involved in the upcoming Liberty rate case and thus may learn helpful information at the hearing.
5. As noted above, Mr. Tillman and Mr. Balashov will not speak, they merely wish to monitor the hearing remotely as if they were in the back of the hearing room.

WHEREFORE, Liberty respectfully requests that the Commission:

- A. Allow Mr. Tillman and Mr. Balashov to remotely monitor the January 31, 2023, hearing; and
- B. Order such further relief as may be just and equitable.
