Record Request A (Liberty)

Please confirm whether any customers' bills have been impacted, or will be impacted, by the errors and corrections Liberty has made to the EV-L and EV-M rates since July 2022.


Record Request B (Liberty)

- (i) Please refer to page 5 of the Settlement Agreement in Docket No. DE 20-170. Please confirm whether the input sources provided on June 15, 2023 for the G-1 and G-2 revenue requirements (i.e., Att. HMT-1 DE 22-035 reference 8-1-2022 and Att. DE 19-064 rev req Order No. 26,537) for on-peak, off-peak, credits, etc. are correctly reflected in calculating the time-varying kWh rates for EV-L and EV-M, respectively, per the Settlement Agreement.
- (ii) Please ensure, or provide an explanation confirming, that the distribution rates on tariff pages 128 and 133 match the rates calculated in the model, as provided under Docket Nos. DE 20-170 and DE 22-035, and that the page numbers are also correctly reflected in the latter docket.


Record Request C (DOE)
