Dear LRWC Water customer,

On January 15, 2021 Lakes Region Water Company, Inc (LRWC) filed a petition for a general rate change with the New Hampshire Public Utilities Commission ("NHPUC").

This general rate change covers the increased operating costs since the last general rate case in 2015, plus provides additional revenues in support of LRWC's infrastructure investment and operations. Over the past 5 years LRWC has made infrastructure improvements in various divisions that were necessary to enhance water supply capabilities in order provide additional water capacity and water quality for our customers.

The Company has proposed and requested a consolidated rate increase of 18.10% for all customers, and, in the event that consolidation is not approved, the Company has proposed stand-alone rate increases ranging from 17.21% (general customers to 172.81% as follows:
