Procedural Order Re: Request to Modify Procedural Schedule


On October 6, 2022, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty (Liberty), with the assent of the New Hampshire Department of Energy (DOE), and the Office of the Consumer Advocate, filed a letter requesting the Commission to reschedule the hearings scheduled on November 8 and 9, 2022, and approve the following proposed modified procedural schedule:

DOE Testimony	September 16, 2022
Data Requests (DRs) to DOE	September 26, 2022
DOE Responses to DRs	October 11, 2022
Technical Session/Settlement Conference	October 24, 2022
Liberty Rebuttal Testimony	October 31, 2022
Settlement Conference	November 8, 2022
Date for Filing Any Settlement	November 22, 2022
Hearing Dates, Two Full Days	Early December 2022

The proposed procedural schedule would partially amend the procedural schedule approved on August 2, 2022.

It has been determined that the proposed modified schedule is in the public interest and, therefore, the foregoing modified procedural schedule is approved. The November 8 and 9, 2022 hearing dates have been rescheduled to Wednesday, December 7, and Thursday, December 8, 2022, starting both days at 9:00 a.m. The hearings will be conducted in person, in accordance with the hearing guidelines issued on June 13, 2022.
