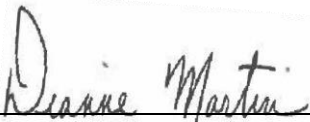
Liberty Utilities (EnergyNorth Natural Gas) Corp. d/b/a Liberty Utilities (“Liberty”) has filed a motion for confidential treatment of certain discovery responses pursuant to Puc 203.08. Under Puc 203.08(b)(1), a motion for confidential treatment must include “[t]he documents, specific portions of documents, or a detailed description of the types of information for which confidentiality is sought.” Liberty’s motion includes documents, however Liberty has redacted the specific portions of those documents for which it seeks confidential treatment. Liberty has not provided unredacted versions of the documents.

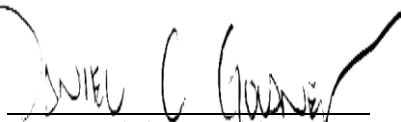
Liberty’s motion for confidential treatment is, therefore, incomplete. The Commission cannot rule on the appropriateness of treating information as confidential if it cannot read and evaluate the information.

It is, therefore, **ORDERED**, that Liberty shall file, within 10 days of this order, unredacted versions of the documents for which it seeks confidential treatment; and it is

FURTHER ORDERED, that, in the event Liberty does not file, within 10 days of this order, unredacted versions of the documents for which it seeks confidential treatment, Liberty’s motion shall be **DENIED**.
