Joint Petition to Approve Pole Asset Transfer

Dear Ms. Howland:

On April 2, 2021, representatives of Public Service Company of New Hampshire d/b/a Eversource Energy and Consolidated Communications of Northern New England Company, LLC d/b/a Consolidated Communications (collectively, Petitioners), New England Cable and Telecommunications Association Inc. (NECTA), the Office of the Consumer Advocate, and the Commission Staff met in technical session to discuss preliminary issues relevant to this proceeding, including: (1) the development of a procedural schedule for the docket; and (2) the NECTA objection to the Petitioners' request for confidential treatment.
