Dear Mr. Aguiar:

On April 20, 2021, Axsess Energy Group, LLC (Axsess) submitted an application with the Commission to renew its registration as a provider of electric aggregation service.

Commission Staff filed a memorandum on April 27, 2021, summarizing its review of the application and recommending that a waiver be granted of the renewal application filing deadline under N.H. Admin. R., Puc 2003.06(a) and that Axsess's registration renewal be approved for a two-year term beginning on March 10, 2021, pursuant to Puc 2003.06(e)(1).

The Commission has granted the recommended rule waiver, having found that it would serve the public interest and would not disrupt the orderly and efficient resolution of matters before the Commission, under Puc 201.05. Accordingly, Axsess's application for registration renewal is approved, effective as of March 10, 2021, under Puc 2003.06(e)(1). The renewed registration is for a term of two years and expires at the close of business on March 10, 2023. Pursuant to Puc 2003.06(a), you must submit your next renewal application at least 60 days prior to the expiration of the approved registration term, on or before January 9, 2023.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Admin. R., Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at:
