

## AFFIDAVIT OF PATRICK C. MCHUGH

**I, Patrick C. McHugh, being duly sworn, do hereby depose and state as follows:**


1. I have been retained by Consolidated Communications ("Consolidated") for various legal and consulting services. As part of my duties and responsibilities for Consolidated, I represent Consolidated in various matters before the New Hampshire Public Utilities Commission (the "Commission").

2. On September 8, 2021, the Commission issued Order No. 26,516 in Docket No. DT 21-105 (the "Order"). Among other things, the Order required Consolidated to: (1) publish a copy of the Order on its website within two (2) business days and (2) provide a copy of the order to: (i) the Town Clerks of Peterborough and Temple, New Hampshire; (ii) the New Hampshire Department of Environmental Services; (iii) the New Hampshire Department of Transportation; (iv) the New Hampshire Department of Natural and Cultural Resources; and (v) the New Hampshire Attorney General, all by overnight delivery for receipt no later than September 13, 2021. Order at ps. 5-6.

3. On September 10, 2021, at the direction of the undersigned, members of Consolidated's Marketing Department caused a copy of the order to be published on the portion of Consolidated's website dedicated to such notices. A screenshot of that web page is attached to this Affidavit to verify that the Order was published.

On September 9, 2021, at the direction of the undersigned, a member of Consolidated sent via Federal Express, for overnight delivery on September 10, the Order to the Town Clerks of Peterborough and Temple, as well as the New Hampshire administrative agencies referenced in paragraph 2 above.
