

Dear Chairwoman Martin:

I am writing to ask the Commission to modify the existing procedural schedule. On October 5, 2021, Liberty Utilities (EnergyNorth Natural Gas) Corp d/b/a Liberty agreed to allow the parties Department of Energy (Energy) and the Office of the Consumer Advocate (OCA) to file additional data requests following the October 13, 2021 technical session, as has traditionally been the case. Energy has proposed data requests, if needed, by October 15th, and has asked Liberty to file data request responses by October 20th. Liberty proposed an October 22nd response date instead, (as it did for the parallel Keene Division cost of gas docket, Docket No. Dg 21-132). October 22, 2021, is the last business day before the hearing scheduled on Monday, October 25, 2021.

While Energy appreciates that Liberty does not wish to commit to a deadline it is not confident it can meet, Energy needs an opportunity to review responses in advance of hearing. In addition, as one set of data requests has already issued in this docket, Energy does not anticipate numerous additional requests.

Liberty and the OCA were emailed a draft of this letter at 11:20 a.m. this morning. Counsel of each party were called at 3:30 p.m. The undersigned does not have their response with regard to Energy's proposed data request response deadline.

Accordingly, Energy asks the Public Utilities Commission to supplement the approved procedural schedule as follows, notwithstanding Liberty's objection to the response date:
