To provide clarification with what has changed on these approved pages, UES hereby resubmits the redline versions of these pages which were previously included in what has been marked as Exhibits 3 and 4. Please note, that aside from the issued date and required approval designation listed in the line at the bottom of each of these pages, no other changes have been made compared to what UES included with its initial filing, dated September 23, 2022, in this docket.

In addition to these filed tariff pages, changes to UES's Summary Of Whole House Residential Time Of Use Rates And Electric Vehicle Rates, Page 5-A (included herein for effect December 1, 2022) are necessary, for effect January 1, 2023, in order to incorporate the approved January through July 2023 G1 class Renewable Portfolio Standard (RPS) Charge which is shown on page 75 (also included herein). As discussed in the prefiled testimony included as part of Exhibits 3 and 4, UES will file this page in compliance with the appropriate Order and docket no later than 30 days prior to January 1, 2023.
